Reason for event: This event will be held in conjunction with the ECCSS Summer Festival (August 6 from 10 a.m. - 11 p.m.)

About the Event:

- Two sessions will be held on Saturday, August 6 (3 - 5 p.m. and 6 - 8 p.m.)
- Sessions will be limited to 15 people each. If the sessions sell out, a waiting list will be started and you may be contacted if an opening becomes available.
- Participants will be using watercolor paints, and all needed art supplies will be provided.
- Participants are responsible for bringing their own drinks/beverages.
- Please wear clothes that can get messy. Watercolor typically washes out, but this is not guaranteed. Aprons are suggested, but will not be provided.

Waiver of Liability Agreement:

Each participant is **required** to fill out this form **prior** to attending a "Brush and Blush" session at Elk County Catholic High School, 600 Maurus Street, St. Marys, PA 15857. Each participant must sign and submit this waiver in order to participate in the event.

RELEASE/WAIVER: "In consideration for my participation in Brush and Blush, I release, waive, discharge and covenant not to sue Elk County Catholic School System, their officers, administration, agents, or employees, including Pete Winklbauer (hereinafter referred to as Releasees) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, injury or death, that may be sustained by me, other participants or to any property belonging to me or other participants while participating in such activity, or while in, on or upon the pre Blush and Brush activities (including, but not limited to creating visual arts and consuming alcohol), and I am voluntarily participating in the activities knowing that the activities may be hazardous to myself and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, that may be sustained by my me or other participants or any loss or damage to property owned by me or other participants, as a result of my participation in Brush and Blush. I further agree to INDEMNIFY AND HOLD HARMLESS the Releasees from any loss, liability, damage or costs, including court cost and attorney fees that I may incur due to my participation in Brush and Blush. I EXPRESSLY REPRESENT THAT I UNDERSTAND that some of the activities will include, but not be limited to, creating visual arts and consuming alcohol and that I have informed Releasees, in writing, of any physical or mental condition that might have a negative or undesirable effect on my participation prior to, or contemporaneously with the signing of this Agreement. In the event of a medical emergency, I will be financially responsible for any and all expenses associated with medical treatment. It is my express intent that this Waiver of Liability Agreement shall bind the members of my family and spouse, if I am alive, and my heirs assigns and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge, and covenant not to sue the above named Releasees. I further agree that this Waiver of Liability Agreement shall be construed in accordance with the laws of the State of Pennsylvania.

PHOTO CONSENT: "I agree that Elk County Catholic School System may use photos from the event in the routine promotion of its activities.

CONTROL AGREEMENT: "I hereby agree that I will hold only myself responsible for consuming alcohol and the amount of alcohol I consume, and that I will practice good judgment if I choose to consume alcohol. I authorize the instructor to cease my access and consumption to alcohol, stop my consumption of alcohol and call the emergency contact person on this form if he feels, in his sole discretion that I have had too much to drink.

"In signing this release, I ACKNOWLEDGE AND REPRESENT THAT I HAVE READ the above Waiver and Liability Agreement, I UNDERSTAND IT AND SIGN IT VOLUNTARILY as my own free act and deed; no oral presentations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least twenty-one (21) years of age and fully competent."

All participants must sign this form to participate in Brush and Blush (even if you choose not to consume alcohol).
