- Divorced or separated parents, who are billed separately for tuition, must **each** submit an application.
- Include a **COPY** of your **2017 W-2** and **2017 PA Income Tax Return** with your application. Please **DO NOT** include the originals!
- All documents requested must be included for application to be processed
- Application must be postmarked no later than **April 16, 2018**
- Mail Application, W-2, PA Income Tax Return and **\$15 processing fee (made payable to Tuition Assistance Program)** to:

❖ **ECCSS Financial Aid Application (pink)**

- One application per family (K-12)
- Divorced or separated parents, who are billed separately for tuition, must **each** submit an application.
- Include a **COPY** of your **2017 W-2** and **2017 PA Income Tax Return**
- **The *Catholic Diocese of Erie Application* MUST BE COMPLETED in order to qualify for *additional* Financial Aid if available.**
- Application must be postmarked or delivered to the ECCSS Finance Office in the Administration Building by **April 16, 2018**.
